

I am including additional information that came from some of the most recent AB Resolutions that do effect some of our members.

AB Resolution 16-22: Motion to provide compensation to members who paid for a membership that would provide them a printed CQ

Region 12 makes the motion to extend Memberships in this schedule due to the removal of the Communique in a paper format:

-Memberships purchased between January 1, 2014 and March 31, 2014: No adjustment

-Memberships purchased between April 1, 2014 and June 30, 3014: Extend 3 months

-Memberships purchased between July 1, 2014 and September 30, 2014: Extend 6 months

-Memberships purchased between October 1, 2014 and December 31, 2014: Extend 9 months

-Memberships purchased between January 1, 2015 and current : Extend 1 year

No new member cards will be sent, but the extension is to be reflected in

the SFI database. If approved, the AB requests to have this completed and inform the membership by 14 days after the vote closes.

Motion carries.

AB Resolution 16-21: Motion to deliver membership packets either by electronic means or mail

Region 12 makes a motion to allow Membership Processing to provide the membership at large a choice to receive their membership packet via electronic methods, or mail, within the currently approved cost structure.

Motion passed.

For any crewmembers who fall into the category of the above mentioned AB 16-22, please keep track of your membership expiration to insure they adjusted your date. If you do not see that in about a month, let me know so I can contact fleet to see what is going on.

Please review the Time in Grade requirement in Regulation 100. If you feel that you qualify for a promotion, see your Department Head. They will assist you in completing the chapter promotion worksheet which can be found on our website and having it submitted to the First Officer. The link submitted to the First Officer. The link above will also bring you to the chapter forms.

Remember that for Officer ranks, OTS is a prerequisite for promotion to Ensign and OCC for promotion to Lieutenant Commander.

Also for Marines and MACOs. do Also for Marines and MACOs, do not forget that you have other pre-requisites for promotion and this includes the enlisted ranks. If you're a Marine and your Marine status is "Active" then you must follow the Marine Promotion guide-lines in Regulation 100. If you're a MACO and that unit is your primary duty assignment, then you too duty assignment, then you too must follow the MACO promotion guidelines in Regulation 100.

Also for Department Heads, you must be qualified as a Bridge Officer for your particular department. For more information about the SFA Bridge Officer Certification Program please use the link below.

### Star Trek Cast: MAJ Hayes By www.startrek.com

Colonel West was a Starfleet officer in the late-23rd century. In that capacity, he was a member of the conspiracy to sabotage peace talks between the Federation and the Klingon Empire in 2293.

West presented Operation Retrieve, the plan to infiltrate Klingon space and rescue James Kirk and Leonard McCoy, to the Federation President after the two Starfleet officers were convicted of the assassination of Klingon Chancellor Gorkon. The president overruled the plan, however, choosing to respect interstellar law in the matter.

Later, at the Khitomer Conference being held near the Romulan border, West disguised himself as a Klingon and attempted to assassinate the Federation President. Taking position behind a large window and taking aim at the president with a Sniper rifle, West prepared to fire, but missed at the last instant as Captain Kirk pushed the president out of the way. After Captain Spock announced

that another conspirator, Lieutenant Valeris, was in custody, West took aim at Valeris, intending to eliminate her to prevent her from testifying, but was stopped when Scotty burst through the door, shooting him with a phaser. West was thrown through the glass and fell to the ground, dying on impact. Examining the body, Colonel Worf noticed that West's blood was not Klingon, and unmasked him, revealing West's role in the conspiracy. (Star Trek VI: The Undiscovered Country)

#### Background information

Colonel West was portrayed by Rene Auberjonois, who later portrayed Constable Odo in Star Trek: Deep Space Nine. He noted, "I did it because Nick Meyer is a personal friend and asked me to." (Cinefantastique, Vol. 23, No. 6, p. 39) Recalling how Meyer invited him to play the part, Auberjonois said, "He called months before they started it. He said, 'It would be a hoot if you came and did a day's work on it.' ... I did it as a lark." (Star Trek - Where No One Has Gone Before, paperback ed., p. 173)

West was named after Lt. Colonel Oliver North, who participated in the Iran–Contra affair. (Cinefantastique, Vol. 22, No. 5) In fact, West was styled after North and was essentially a thinly veiled political jab made by Nick Meyer. (Cinefantastique, Vol. 23, No. 6, p. 39)

West never actually appeared in the theatrical version of Star Trek VI, since his scenes were deleted. However, he can be seen on the VHS and DVD releases of the movie, but is not listed in the cast credits at the end of the VHS or DVD. Rene Auberjonois was under the impression West's involvement in the film had been completely cut until he learned, from an audience at a Star Trek convention, that it had been reinstated in the VHS version. (Star Trek - Where No One Has Gone Before, paperback ed., p. 173)

In 2009, The Undiscovered Country was re-released on DVD, omitting the West scenes, as it was the first DVD release of the theatrical cut. The theatrical cut is also the only version released to date on Blu-ray. While identified in dialogue as a "colonel", West wore the uniform of a Starfleet vice admiral (equivalent to a lieutenant general). The display that West shows during the briefing, does mention a Starfleet Marine Corps, suggesting (along with his rank) that West is actually a Marine himself.

His mirror universe counterpart appeared in the novel The Sorrows of Empire.

Never 'assume' that something can't or won't happen in your area. We all know how 'that' will end up. Both the National Oceanic and Atmospheric Administration [http://www.nws.noaa.gov/com/weat herreadynation/prep.html] and the Centers for Disease Control & Prevention

[http://www.cdc.gov/features/beread y/] offer handy guides on how to prepare. It doesn't even need to be a big, local disaster. Right now there are several small local towns without power due to a forest fire. The fire is nowhere near them, but has taken out parts of the power grid headed into their area.

If you want to take this into a larger venue [your work place, school, your local church, etc.] Ready.gov has an entire month's worth of plans.

\*\* Now with another International Marine Muster come and gone and with the major awards season over, now is a good time to check out your personnel records on the database. No one's going to know something is missing but you so it's a good to get in the habit of reviewing your personal records every couple of months or so.

And besides, you may discover an award or two you didn't know you received. That's always a nice surprise.

It's a fact of life in electronic record keeping that sometimes things go missing. An email may get eaten by a spam folder. Records can be lost on a hard drive. It is the responsibility of the individual to keep a copy of all his personal records, awards received, courses completed, etc. If you find an error, it's certainly acceptable to point it out and request the data be added, updated or changed. Just know that you'll need to provide documentation so that the appropriate correction to the database. Documentation can be a scanned copy of the certificate, an email from the issuing authority, a copy of a Unit or Brigade report noting the award, etc.

I can't emphasis this point enough: if it can't be documented, it can't be changed, corrected or added. If this all sounds familiar, it's something I try to stress every few months or so. It's never a good idea to wait until the last moment to discover something's missing, especially if you're getting ready for a formal dress event like your Unit Holiday formal dinner or an upcoming Brigade Muster.

Just think of it as 'preventative maintenance'.

Greetings Marines,

There were newer articles on the site but in six weeks the site was hacked three times and the articles got corrupted. I had to delete and re-add them. Then the site got hacked again and the last time I didn't add the articles back and remove the ability to add articles to stop future hacks. Luckily after I made that change the site hasn't gotten hacked again. My primary focus is getting the report-ing forms working and then con-centrate or getting the other data moved. As I have no web team staff members so if you know WordPress and would like to volunteer to assist please contact me.


